Product description:

This EPD covers unplastified polyvinyl chloride (PVC-U) pipes from d10mm to d400mm (up to d600mm for ventilation pipes) for use in a wide range of applications including ventilation, industrial applications, water treatment systems, chemical processing.

Product specification

This EPD covers all pipes the following product groups: PVC04, PVC06, PVC10, PVC16, PVC25, VPVC.

All product numbers start with the product group as a prefix, before the relevant dimensions are included.

Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. The data quality of the raw materials in A1 is presented in the table below.



LCA: Scenarios and additional technical information

The following information describe the scenarios in the different modules of the EPD.

A4: The pipes are transported 1200km from Sprockhövel, Germany to Langhus, Norway by truck, before delivery to customer which is set to 300km. The distance of 300km is given in newer PCRs as a default value for Norwegian domestic transport.

A5: Has not been included due to there being several ways of installation. Project specific EPDs available on request.

C1-C4: Has not been included as it is assumed that the pressure pipes are left as is after end of life.
